Children's Code Task Force Thursday, February 16, 2023 4:00–5.30 p.m.

I. Welcome from Judge Catherine Begaye, Task Force Chair

Judge Catherine Begaye, Presiding Children's Court Judge, Second Judicial District, called the meeting to order and welcomed the task force members to the meeting. During her remarks, Judge Begaye made the following points:

-She is still working with IT personnel at the Judiciary on a platform for future meetings; and

-She welcomed a new Task Force member, Diana Garcia. Ms. Garcia is a Deputy District Attorney and her initial thoughts regarding needed reforms is to better align the Children's Code with the Children's Court Rules.

II. Recap: Kathleen Sabo

Ms. Sabo briefly re-capped the first task force meeting, which was held on January 19, 2023. She noted that the Children's Code Task Force will focus its initial efforts on a review of welfare provisions in the Children's Code.

During the first meeting. we heard from David Schmidt and Tony Ortiz, who both worked on the drafting of the original Children's Code in the early 1990's. Mr. Schmidt and Mr. Ortiz cited the following as lessons learned from that previous effort:

-It was vitally important to have Native American representation on the subcommittees that supported development of the Children's Code;

-The task force will need to determine a process for developing its recommendations. Consensus-building is the key to success;

-As societal and cultural values evolve, those changes should be reflected in a revamped Children's Code;

-Inclusiveness and civil discourse are vitally important; and

-Emerging research on substance abuse and brain development in youth will inform our work.

III. Sub-committees

Ms. Sabo advised that the task force will initially create two sub-committees that will focus on: 1) improving responses to poverty and substance abuse; and 2) crossover youth who have contacts with the child welfare and juvenile justice systems. Both sub-committees will intentionally fold in issues that impact Native American children and families.

Next, task force members selected the sub-committees they want to work on.
